### 2016 Rates (no increase from 2015):

٠	Annual Rate for Monthly Sewer Service (if paid by 1/31/2016; incl. \$2/mo. discount)	\$876.00
٠	Monthly Discount for payment by ACH through D/NSSD system	\$2.00
٠	Monthly Commercial Base Volume Charge (fixed rate per assigned CAF;7,908 gallons)	\$75.00
٠	Commercial Excess Volume Charge (per 1,000 gallons)	\$9.40
٠	Commercial Billing Surcharge (charged monthly if any flow recorded)	\$9.00

2016 Annual Debt Service Fee (either prepaid in 2015 or on 2016 taxes) \$1,000.00

**All residential service** will be invoiced on the first of each month and due by the last business day of the month. Given the monthly charge does not vary for residential accounts; the billing office will mail statements monthly around the 10<sup>th</sup> of each month to capture straggler payments. This statement functions as your monthly invoice and will reflect your current balance due, along with any payments made and invoices issued during the prior month. Payments are due at month-end regardless of statement receipt date.

**Commercial accounts** will be invoiced on the same schedule as residential accounts. The commercial invoice from the first of the month will include that month's base charge (for their assigned CAF/base volume charge) and any excess volume, if applicable, from the prior month. Volume readings are typically provided to the billing office by the 5<sup>th</sup>-10<sup>th</sup> of each month so commercial statements/invoices will also be issued on/around the 10<sup>th</sup> of each month.

**Monthly Statement of Balance Due and Prior-month Activity** All users not paying by the District's ACH program and all commercial accounts will receive a one-page Statement & Invoice, sent by mail, reflecting:

- Balance Forward, if applicable
- Activity for the last 30 days (payments posted, invoice(s) issued, finance charges applied, etc.)

A remittance envelope will be provided for all users not paying by their bank's bill-pay service.

The monthly statement/invoice will reflect the total amount due by the last day of the month to keep or bring your account current. All payments received *through the monthly statement date* will be reflected with check numbers noted. Finance charges are assessed on the 5<sup>th</sup> of each month.
